ORDINANCE NO. 6A

1902

AN ORDINANCE CONCERNING THE TOWN SEAL.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF RIVERSIDE.

Section 1. That the town of Riverside shall have a corporate seal which impression shall be as follows: Around the outer edge the words "the Town of Riverside Wyoming" and in center the words "Corporate Seal."

Section 2. This ordinance shall be in full force and effect on and after its passage.

ORDINANCE NO. 150

AN ORDINANCE PROVIDING FOR A GENERAL PENALTY FOR VIOLATION OF ANY OF THE PROVISIONS OF THE ORDINANCES OF THE TOWN OF RIVERSIDE, WYOMING PASSED ON AND AFTER THE DATE OF THIS ORDINANCE; PROVIDING FOR A PENALTY WHEN A SPECIFIC ORDINANCE DOES NOT PROVIDE ONE; PROVIDING THAT ALL ACTIONS SHALL BE BROUGHT IN THE CORPORATE NAME OF THE TOWN OF RIVERSIDE; PROVIDING FOR THE DESPOSITION OF RECOVERIES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR AN EMERGENCY.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF RIVERSIDE

GENERAL PENALTY - REMEDIES GENERALLY - CONTINUING VIOLATIONS. Whenever in this Code or in any ordinance, resolution or regulation promulgated on this date or hereafter by any officer or agency of the Town of Riverside under authority bestowed in him by law or ordinance, any act is prohibited or is declared to be unlawful or an offense or a misdemeanor, or the doing of an act is required, and no specific penalty is provided therefor, the violation of any such provision of this Code or any such ordinance, resolution or regulation shall be punished by a fine of not more than \$750.00 provided, that the imposition of any such fine shall not bar institution of appropriate legal actions or proceedings by the municipality to restrain, correct or abate the violation nor shall the institution of such legal actions or proceedings be deemed a bar to the imposition of such fine. In addition to the fine imposed under this section, such violators shall be taxed ten dollars as court costs.

Except as otherwise provided, each day any violation of this Code or any such ordinance, resolution or regulation continues shall constitute a separate offense.

ORDINANCE NO. 150

PENALTY WHEN ORDINANCE DOES NOT PROVIDE - WHO LIABLE FOR PENALTY. Whoever violates any provisions of any ordinance of the Town of Riverside, whether included in these revised ordinances or ordinances hereafter enacted, shall, unless otherwise provided, be liable for a penalty as stated in the GENERAL PENALTY section of this ordinance for each offense. When anything is prohibited in an ordinance, not only the person actually doing the prohibited thing, but also the employers and all other persons concerned therein, shall be liable for the penalty prescribed.

ACTIONS FOR PENALTIES OR FINES. All actions brought to recover any penalty or fine shall be brought in the corporate name of the Town of Riverside.

DISPOSITION OF RECOVERIES. The recoveries, when collected, shall be paid into the treasury of the municipality.
